Greater Miami & Miami Beach Travel Information

If you are planning travel to Greater Miami, we ask that you do so responsibly and practice CDC safety guidelines.

Non-U.S. travelers who have recently visited Brazil, the United Kingdom, Ireland and 26 countries in Europe (the Schengen Area) may not enter the U.S. at this time.

The Federal Government requires that all travelers to the U.S. produce proof of a recent negative test for COVID-19 test prior to entry and within three days before their flights.

The CDC is also recommending periods of self-quarantine or self-isolation after entry into the United States and that travelers get tested 3-5 days after travel.

For the most up-to-date information on travel restrictions, please check with the <u>US Department of</u> <u>State</u> and the <u>CDC Guidance for Travel</u> as guidelines and restrictions continue to evolve.

Miami-Dade County COVID Guidelines

There is currently no curfew in Miami-Dade County.

Revised Business Guidelines & Industry Recommendations are provided in the COVID Safety Guidelines, A Guidebook for Residents and Commercial Establishments which includes recommendations and best practices for Hotel and Lodging, Food and Beverage (Restaurants), Parks and Outdoor Recreation and Entertainment, and Meeting Venues.

Masks/Facial Coverings

Please be safe! Kindly wrap your face and practice social distancing when you are exploring our beautiful tropical paradise!

Miami-Dade County requires key COVID safety precautions including masking, distancing, and disinfecting at all County spaces, including libraries, County parks and County buildings.

A federal mask mandate remains in place for all Miami-Dade County government facilities including public transit, Miami International Airport and PortMiami.

Local businesses are no longer mandated to require COVID safety precautions including masking. However, we urge our community to continue using common sense to prevent the spread of the virus and to treat those around you, particularly in public spaces, with respect by keeping your mask on when around those outside your household.



The GMCVB's 'Stay Safe Wrap Your Face, Vacation Responsibly', campaign brings awareness to the importance of mask use while enjoying the destination. The creative marketing campaign is designed to educate visitors on the use of masks to prevent the spread of the COVID-19 virus, prioritizing COVID safety by stressing to visitors that to vacation responsibly, you must wear protection.

For the Health & Safety of your Clients: Our vendors and service providers enforce the below policies at varying levels as required by the local health authorities as well as their own corporate (Health & Safety) H &S Policy for the health and safety of your clients. Clients will be required to follow the below policies or be denied services. There will be no refund if services are denied due clients declining to comply with the service provider's H & S Policies.

Besides this, the general requirements as listed by various hotels, tour companies, attractions, restaurants, etc. are listed below.

Each hotel, venue, attraction, tour company, restaurant, etc. may choose to enforce their own additional health and safety requirements. These will be applicable to the respective clients and same will be communicated at the time of reservations.

- Face Coverings: All clients (ages 3 and up) are required to wear face coverings when on property and on tours. Any client who refuses to wear a mask will be denied entry to the property, on tours and any venue. As per government or vendor regulations, visitors are required to wear face masks.
- <u>Health Screening</u>: Clients may be subject to temperature screening prior to being permitted on the property on tours & at admission venues. Anyone displaying a temperature of 38° C or higher may be refused entry.
- <u>Physical Distancing</u>: Best practices in physical distancing will be implemented including the use of floor markers, directional arrows, communication signage, installation of plexiglass at service counters, and reduced guest capacity at all locations.
- <u>Reduced Occupancy</u>: Several of our vendors and service providers practise reduced occupancy to further enhance safety standard.
- Focus on Sanitizing: The property and all tour and admission venues have increased the cleaning frequency for high-contact areas using approved products as well as providing guests with access to hand sanitizer stations throughout the property.
- <u>Travelled Outside Canada</u>: Visitors who have travelled outside of Canada within the last 14 days may not be permitted to visit the attractions, the operator reserves the right to deny access.
- <u>Contact Tracing</u>: Hotels, Sightseeing Tours, Admissions venues, etc. may be required by Provincial & Federal Health Authorities to collect contact information from visitors. Our service providers operate in compliance of local, national, and international privacy policies and will not use email addresses for the purposes of marketing without the permission of the clients.
- Outside Food & Beverages: In the interest of maintaining health & hygiene standards, many establishments may restrict client's bringing in outside food/beverages into their premises, establishments, facilities and transportation.
- <u>Recuse yourself from this tour</u>: In the light of the current COVID 19 circumstances, for the safety of all the other guests, you should not attend our tour or any part of it (if you are already on the tour) should you or anyone else who is/was in contact with you is showing any signs or symptoms of illness.
