Change & Cancellation Policy

- You may request changing your cruise itinerary or departure date up to 91 days before the scheduled sailing. Cruises may not be changed within 90 days of sailing. All changes will incur a \$250 per person administrative fee and will be subject to fare increases - if applicable.
- In the case of Non-performance of Cruises: If the Cruise Lines, cancels your cruise, or delays your cruise for more than 3 calendar days, and you do not accept an alternative cruise or choose not to travel on a delayed cruise, you are entitled to a refund of cruise fare and charges for accommodations, services and facilities (including port fees, taxes and other ancillary charges paid to the carrier relation to your cruise) for the cancelled or delayed cruise.

Should we purchase Travel Insurance? Travel Insurance is highly recommended for all clients. | 5 | Two Adults + 1 Youth sharing room | 2 Adult Sharing Twin Rate + 1 Youth Rate |
| 6 | Two Adults + 1 Child + 1 Youth sharing room | 2 Adult Sharing Twin Rate + 1 Youth Rate + 1 Child Rate |
| 7 | One Adult + 1 Youth sharing room | 1 Adult Single Occupancy rate + 1 Youth Rate |
| 8 | One Adult + 1 Youth + 1 Child sharing room | 1 Adult Single Occupancy rate + 1 Youth Rate + 1 Child Rate |

Note: City Fire Code limits the number of beds in a room to a maximum of two beds irrespective of Single, Twin, Triple or Quad occupancy.
